## **Buying Influence to Injure and Kill**

n April 1, 2021, HHS announced that it was establishing a nationwide network of "trusted voices" to encourage people to get COVID-19 vaccinations. The trusted voices were labeled "The COVID-19 Community Corps." Among the founding members of this Orwellian campaign to poison the populace through deceptive marketing were the nation's premier medical and health associations, including, but not limited to, the American Medical Association (AMA), American Academy of Pediatrics (AAP), American College of Obstetricians and Gynecologists (ACOG), American College of Physicians (ACP), and American Association of Nurse Practitioners (AANP).

Why would these medical organizations agree to work with HHS to encourage people to get COVID-19 vaccines? The answer is as old as time; they are being paid very handsomely to prostitute themselves and act as shills and huxters for the government. For example, the ACOG alone received \$11 million from HHS.<sup>2</sup> Attorney Maggie Thorp, and her OBGYN husband Jim Thorp, M.D., revealed that receipt of the money was contingent on "ACOG's full compliance with CDC guidance on COVID-19 infection and control." The ACOG is not just a professional organization; it holds great sway over its members. Maggie and Jim Thorp explain:

Meet the American College of Obstetricians and Gynecologists (ACOG). Founded in 1951, ACOG holds itself out as the "premier professional membership organization for obstetricians and gynecologists" and is the leading organization representing physicians and specialists in obstetrical care. ACOG is entrenched across two continents – it has more than 60,000 members and is composed of 12 geographic districts made up of 98 sections spanning North, South, and Central America.<sup>4</sup>

The ACOG had initially taken the position that "[i]n the interest of patient autonomy, ACOG recommends that pregnant individuals be free to make their own decision regarding COVID-19 vaccination." But after HHS made its \$11 million payoff to ACOG, on July 30, 2021, the ACOG changed its position on the COVID-19 vaccine from one of deference to the mother's decision to one of strongly recommending the COVID-19 vaccine for pregnant women. That recommendation was made in the face of no evidence of the vaccines' safety or efficacy for pregnant women; indeed, the COVID-19 vaccine clinical trials failed to include pregnant women. There was no science to support ACOG's change in position, but the payment of \$11 million certainly explains it.

Flush with its windfall of \$11 million from HHS, ACOG obediently whipped its doctors into line by publishing "key recommendations," including:

The American College of Obstetricians and Gynecologists (ACOG) strongly recommends that pregnant individuals be vaccinated against COVID-19. Given the potential for severe illness and death during

pregnancy, completion of the initial COVID-19 vaccination series is a priority for this population.

ACOG recommends that pregnant and recently pregnant people up to 6 weeks postpartum receive a bivalent mRNA COVID-19 vaccine booster dose following the completion of their last COVID-19 primary vaccine dose or monovalent booster.<sup>6</sup>

All patients who refuse to get the COVID-19 vaccine must have their medical record reflect their refusal. Notably, one of the ACOG "key recommendations" is for the doctor to convince the patient who refused previous vaccination efforts to get vaccinated at the next office visit.

For patients who do not receive any COVID-19 vaccine, the discussion should be documented in the patient's medical record. During subsequent office visits, obstetrician—gynecologists should address ongoing questions and concerns and offer vaccination again.<sup>7</sup>

This hard-sell strategy clearly deviates from ACOG's previous position that "pregnant individuals be free to make their own decision regarding COVID-19 vaccination." A little known fact is that under the "Cooperative Agreement" between HHS and the ACOG that was part of the arrangement to get the millions of dollars from HHS, "the recipient is expected to provide to CDC copies of and/or access to COVID-19 data collected with these funds." That means the patient's decision whether to get a COVID-19 vaccine will likely be reported to the CDC. The CDC is a component agency of HHS.

The \$11 million payoff from the HHS turned the ACOG into liars. One of the "Key Messages" about COVID-19 from the ACOG is the claim that the COVID-19 vaccines do not cause infertility, spontaneous abortion, or fetal defects. That assurance is false. Evidence from Pfizer's studies reported in January 2021 (and publically revealed under an FOIA order on April 28, 2023) showed that rats who had taken the COVID-19 vaccine were twice as likely to suffer pregnancy loss. Furthermore, the Pfizer studies showed a 14-fold increase in birth abnormalities among the COVID-19 vaccinated rats compared to the control group. 10

On April 29, 2023, it was revealed that in human trials, the Pfizer COVID-19 vaccine was shown to cause spontaneous abortions in 21% of women receiving the COVID-19 vaccine. <sup>11</sup> Babies born to mothers who had been vaccinated suffered damages ranging from pneumothorax to death. <sup>12</sup> Indeed, 19% of the infants explosed to the COVID mRNA vaccine via their mothers' milk suffered from 48 different adverse events ranging from diarrhea to vomiting. <sup>13</sup> Amy Kelly, who is the Program Director of the War Room/DailyClout Pfizer Documents Analysis Project, explains:

Despite Pfizer and the FDA knowing by April 20, 2021, the extent of

damage to fetuses and babies, including the fact that fetuses and newborns had died, on April 23, 2021, inexplicably [CDC Director] Dr. Rochelle Walensky held a White House press briefing where she recommended pregnant women get vaccinated.<sup>14</sup>

ACOG is as culpable as the CDC. While the ACOG had no scientific or medical reasons, they had eleven million other reasons to "strongly recommend[] that pregnant individuals be vaccinated against COVID-19." The ACOG doctors have literally been given a script to follow to deceive and badger their patients into getting vaccinated. The script did not allow for any consideration of each patient's unique health needs or condition. It is a one size fits all recommendation to get vaccinated. There is no proviso in the script for informed consent. It is a script to push, prod, and cajole compliance. The ACOG script prodding pregnant women to get vaccinated remains unchanged despite the mountain of evidence that the COVID-19 vaccines are ineffective and dangerous. It is a violation of the Hippocratic oath to first do no harm. It is not the practice of medicine; it is more the administration of a superstitious religious sacrament.

You realize who is behind this effort to poison and kill mothers and infants when you follow the money. The "CDC Foundation" was created by Congress. <sup>15</sup> It is a public charity that has been given statutory authority to fund the CDC. The CDC accepts funds from the CDC Foundation. Of course, the CDC Foundation wields tremendous control over the CDC. The funds the CDC Foundation provides are then funneled to medical associations such as the ACOG to push doctors into administering vaccines. Take a wild guess who funds the CDC Foundation? The CDC Foundation is funded by all the usual suspects: pharmaceutical companies that make vaccines like Pfizer, Merck, Johns & Johnson, and organizations that profit from vaccines or are funded by those who so profit, like the Bill & Malinda Gates Foundation, the GAVI Alliance, and the World Health Organization. <sup>16</sup> He who pays the piper calls the tune. The powerful pharmaceutical interests use their funding control over the CDC to, in turn, see that those funds are used to control what the doctor tells his patients about the safety and efficacy of vaccines. This is a new spin on trickle-down economics. Any doctor who kicks against the pricks and does not follow orders soon finds himself out of a job.
