
The most significant medical fraud in history is based on the theory that you can prevent illness by injecting poisons into the bodies of healthy people. That is dangerous quackery and sin. All true science has proven the practice of vaccination to be ineffective and unsafe. But the medical establishment has been lured into the superstitious practice, hook, line, and sinker.

Dangerous Quackery

Vaccination is a strange medical practice where instead of the doctor trying to cure a person of a disease to make him well again, the doctor purposely infects a well person with a disease in the hope that his reaction to the infection will be less than it would otherwise be if he had contracted the disease through the environment. Vaccination is not without risk. There can be dire consequences to the practice. There are side effects to vaccination that the medical community calls adverse events that can range from soreness in the injection site to fever, paralysis, and even death. The expectation, which is often not realized, is that the vaccinated person will develop an immunity to the disease and be thus

protected from future infection. Unlike natural immunity from a disease contracted from the environment, which is typically lifelong, the immunity from vaccination, if it is present at all, is fleeting, requiring booster shots.

A study comparing the health of a group of 1,482 unvaccinated adults and children to the national statistics on the health of vaccinated adults found that 6% of the vaccinated population had cancer, while 0% of the unvaccinated group had cancer; 16.67% of the vaccinated population had arthritis, while 0% of the unvaccinated population had arthritis; 48% of the vaccinated population had heart disease, while 0% of the unvaccinated population had heart disease. Studies have found that vaccinated children are more than four times more likely to have autism than unvaccinated children. Vaccinated children are 30 times more likely to develop allergic rhinitis than unvaccinated children. It has been proven that there is a direct correlation between vaccinations and infant mortality. The greater the number of infant vaccinations, the greater the number of infant deaths.

Pediatricians

In 2021, the American Medical Association (AMA) amended its Code of Medical Ethics Section 8.7 to include an ethical responsibility to encourage patients to get vaccinated.⁵ With that, the AMA (being under the thumb of the pharmaceutical industry) has determined that it is an ethical violation for a physician not to encourage patients to accept immunization. A physician cannot be

neutral on the issue of vaccination; he must "encourage" vaccination or be subject to license suspension by their state medical board for violating the AMA code of ethics.

The American Academy of Pediatrics (AAP) is a corporate and government mouthpiece that touts the wares of drug and vaccine manufacturers. Most Pediatricians mindlessly follow the recommendations of the AAP. The AAP advocates strong-arm tactics to coerce parents to vaccinate their children; it advises pediatricians that it is an "acceptable option to pediatric care clinicians to dismiss families who refuse vaccines." The AAP "calls for the on-time, routine immunization of all children and adolescents" and further "reminds pediatricians that every visit is an opportunity to vaccinate." The AAP further recommends "COVID-19 vaccination for all infants, children, and adolescents 6 months of age and older." That is an appalling recommendation in light of the VAERS data showing that the COVID-19 vaccines are associated with 35,347 deaths, 27,113 cases of myocarditis and pericarditis, and 66,462 permanent disabilities as of June 2, 2023. That dangerous recommendation can be explained by the fact that the AAP receives funds from COVID-19 vaccine maker Pfizer. Indeed, the AAP is almost entirely funded by pharmaceutical companies. Among its top ten donors are pharmaceutical giants Johnson & Johnson, Merck, and Sanofi, all vaccine makers. He who pays the piper calls the tune.

Moral degenerates run the AAP. For example, the AAP has issued an official policy statement supporting transitioning prepubescent children from male to female and vice versa. ¹² The AAP thinks that prepubescent children should be allowed to change their gender despite objections from parents. The AAP approves transgenderism and states that it is outdated thinking to opine that a prepubescent child is not mature enough to change his or her gender. The AAP says that parents and doctors should affirm a child's decision to transition from one gender to another and not try to dissuade the child from that course. The AAP calls efforts to stop a child from identifying as or transitioning to a sex other than his or her biological sex "inappropriate," "deleterious," "unfair," "deceptive," and "outside the mainstream of traditional medical practice." The AAP states that it approves children undergoing cross-sex hormone therapy and irreversible transexual "gender affirming" surgeries. The AAP thinks that Pediatric primary care providers should be "a reliable source of validation, support, and reassurance" to prepubescent children seeking to transition from one gender to another. The AAP undermines the authority of parents over their children. In cases where the family objects to their child transitioning from one sex to another, the AAP recommends that pediatricians seek legal help to ensure that they do not violate the local consent laws in their efforts to help the child transition over the objection of the parents.

There is a medical phalanx set up to push parents into vaccinating their children. The Immunization Action Coalition (IAC) provides doctors with a "Sample Vaccine Policy Statement: Ready for you to adapt for your practice." That policy statement template states, in pertinent part that "if you should absolutely refuse to vaccinate your child despite all our efforts, we will ask you to find another healthcare provider who shares your views. We do not keep a list of such providers, nor would we recommend any such physician."

The Immunization Action Coalition is funded "in partnership with the Centers for Disease

Control and Prevention (CDC)" which "provided financial support to IAC." The Children's Health Defense revealed that the CDC has acted as a captured government agency that is under the control of the vaccine industry.

Furthermore, the AAP argues against religious liberties by calling for eliminating religious exemptions to vaccinations. "The AAP views nonmedical exemptions to school-required immunizations as inappropriate for individual, public health, and ethical reasons and advocates for their elimination."¹⁶

Autism

The AAP falsely states that vaccines are not associated with autism. ¹⁷ The AAP makes that statement even though the AAP knows that vaccines cause permanent brain damage. The AAP has posted a 1998 paper written by CDC researchers that showed the measles vaccine causes permanent brain damage. ¹⁸ Autism is brain damage caused by vaccines. That 1998 study does not stand alone. There are 214 peer-reviewed studies linking vaccines and autism. ¹⁹ Several studies have shown that a vaccinated child is more than four times more likely to be stricken with autism than an unvaccinated child. ²⁰

Steve Kirsch reports that a "large clinical pediatric practice I am personally very familiar with has eschewed the use of all vaccines and acetaminophen and achieved a zero autism rate over the past 25 years even though autism rates were skyrocketing in adjacent clinics." Another pediatric clinic, Homefirst Medical Services, which has treated more than 30,000 children over a 47-year period, found not a single case of autism among the unvaccinated children. Compare that to the shockingly high rate of 1 in 54 autistic children (as of 2020) reported by the CDC. Incidently, Steve Kirsch conducted a study and found that the rate of autism is closer to 1 out of 3 children.

Dr. Lyons Weiler, Ph.D., is the Scientific Director of the Bioinformatics Analysis Core and a Senior Research Scientist at the University of Pittsburgh. Dr. Weiler got a call from one of the top autism experts in the world, who told Dr. Weiler: "We [autism experts] all know vaccines cause autism. We just aren't allowed to talk about it." Steve Kirsch explains that if autism researchers publically admitted that vaccines cause autism, "they would lose their funding, their job, their license to practice medicine, their hospital privileges, their board certifications, etc." 25

Vaccine Bounties

When pediatricians recommend vaccines, they do so not because vaccines have been proven safe and effective. The doctors recommend vaccines because any other recommendation would likely cause them to lose their license to practice medicine. Pediatricians are practicing medicine while under the sword of Damocles. Furthermore, Pediatricians are often paid a bounty if they maintain a high percentage of vaccinated child patients.²⁶ If they allow unvaccinated child patients in their practice, it puts their bounty payments at risk. That is why most pediatricians will not allow a new child whose parents refuse to vaccinate their child into their practice. Incidently, U.S. Congressman

Thomas Massie discovered that physicians were paid bounties to push COVID-19 vaccines.²⁷ The doctors were given progressively increased payments for each vaccinated patient if certain thresholds were met. Of course, the patient is not told that his doctor is financially incentivized to recommend the COVID-19 vaccine. Nor is he told that the medical board could discipline the doctor if he does not recommend the vaccine.

Conspiracy

There is a malevolent spirit behind vaccines. The practice of vaccination is part of a conspiracy against God and man. While most doctors are unwitting, some are willing minions of that old serpent, called the Devil, and Satan, who are quite happy to kill people for profit.

Hindu Origins

A little-known fact is that the ineffective and dangerous practice of vaccination did not actually start with Edward Jenner; it can be traced to Dhanwantari (1,500 B.C.), who was considered the Vedic Father of Medicine. The practice of injecting vaccines is founded on a Hindu religious superstition. Vaccination is a religious practice that has been proven to be medically ineffective and harmful. In addition to the Hindus, other heathen tribes had practiced inoculation for centuries past. The practice was usually abandoned once the superstitious treatment was found to be useless and harmful. But the enlightened medical doctors of today seem to be slow learners and are thus slow to abandon a practice that has been proven to be dangerous and ineffective.

Vaccination is Sin

The Hindu religion is a heathen religion. God commands us to have nothing to do with heathen practices. "And have no fellowship with the unfruitful works of darkness, but rather reprove them." Ephesians 5:11. We are called on to avoid such practices. "Beware lest any man spoil you through philosophy and vain deceit, after the tradition of men, after the rudiments of the world, and not after Christ." Colossians 2:8.

We are forbidden to do evil in order to obtain some good end. Bad means corrupt the intended good. "And not rather, (as we be slanderously reported, and as some affirm that we say,) Let us do evil, that good may come? whose damnation is just." (Romans 3:8) Indeed, "whatsoever is not of faith is sin." (Romans 14:23)

Christians are religiously bound to care for their bodies as they are the temple of the Holy Spirit. It is a sin to defile our bodies by injecting them with the polluting poisons of vaccines. (1 Corinthians 3:16-17; 6:19-20) The consequent death and illness that flow from vaccination fulfill God's promise to destroy those who would defile their bodies through vaccination.

A person is injected with a pathogen on the theory that the recipient's body will become

immune to the disease. It is a sin to inject a person with an antigen to cause an immune response. That is to "do evil that good may come." That is a sin. See Romans 14:23. But the good that is expected is a phantom; the medical theory of vaccination is fallacious. Job explains: "But ye are forgers of lies, ye are all physicians of no value." (Job 13:4)

Religion of Vaccinology

People have lost sight of the truth that "the life of the flesh is in the blood." (Leviticus 17:11) They are thus easily tricked into polluting their blood with vaccines. They do not realize that vaccination is a religious ritual wherein the blood is contaminated.

The disciples in this new religion of Vaccinology are kept ignorant of the cost to their bodies and souls. But the cost is real; they are being sacrificed by poisoning and, tragically, unwittingly sacrificing their children to the gods of Vaccinology.

Vaccinology is a belligerent religion. It will seek to persecute those who are of a different faith. The heathen priests of Vaccinology are of the flesh. They will persecute those who have the Spirit of Jesus Christ. The Bible informs us "that was born after the flesh persecuted him that was born after the Spirit, even so it is now." Galatians 4:29.

Vaccination is justified on the same basis as sacrificing children to Molech. God calls it an abomination to sacrifice children to Molech. The heathen religious practice was to immolate the children to appease the pagan god, Molech. God states: "And thou shalt not let any of thy seed pass through the fire to Molech, neither shalt thou profane the name of thy God: I am the LORD." (Leviticus 18:21) Parents would sacrifice their child to Molech to gain future protection against disease, famine, and war. There was tremendous pressure put on families to sacrifice their children for the greater good of the community. It was viewed as beneficial to sacrifice a few for the benefit of the many.

That is the same reasoning behind vaccination. It is understood that vaccines are inherently dangerous and will kill and injure some of those who are vaccinated. Indeed, the pharmaceutical companies and the government acknowledge that vaccines are inherently dangerous, which is the basis for the government granting pharmaceutical companies immunity from civil liability. The government thinks it is beneficial to sacrifice a few for the benefit of the many even when they know that there is no benefit to the many.

Vaccination has much in common with the religion of Molech. It is the sacrifice of the few to protect the many. Doctors know that a certain percentage of children will die and be injured by vaccines. But as with the sacrifice of children to Molech, the medical community claims that "the benefits outweigh the risks and costs for many vaccines including polio, pertussis, measles, mumps and rubella. Thus, the use of these vaccines provides a net saving to society." As with the worship of Molech, the few must be sacrificed for the benefit of society. Vaccination is the perverse ethic of doing evil that good may result. God calls such an ethic a damnable heresy. *See* Romans 3:8. God

condemns it. The child sacrifices to Molech were ineffectual; it was based on mythology. In like manner, vaccination is ineffectual; it is also based on mythology. Just as Molech was no threat, so also viruses pose no threat. The sacrifice of the few to Molech did nothing to protect the many. In like manner, sacrificing the few to vaccination does nothing to protect the many. For example, it has been proven that the COVID-19 vaccine does not prevent the spread of the alleged virus known as SARS-CoV-2 and thus does not offer any immunity to the herd, as was alleged under the vaccine mandates.

Vaccines Kill Infants

There is scientific proof that the more vaccines administered to infants, the higher the infant death rate.³² Mark Blaxill and Amy Becker studied mortality rates during the COVID-19 lock-downs.³³ They discovered a startling fact. Infant mortality actually went down during the COVID-19 lockdowns. There was a significant decrease in the number of infant deaths. Blaxill and Becker attributed that drop to the inability of parents to do well-baby doctor checkups with the obligatory vaccinations. Fewer vaccines = fewer infant deaths. Blaxill and Becker stated:

Starting in early March, expected deaths [for children under 18 years old] began a sharp decline, from an expected level of around 700 deaths per week to well under 500 by mid-April and throughout May. The Centers for Disease Control and Prevention. National Center for Health Statistics Mortality Surveillance System.

As untimely deaths spiked among the elderly in Manhattan nursing homes and in similar settings all over the country, something mysterious was saving the lives of children. As springtime in America came along with massive disruptions in family life amid near-universal lockdowns, roughly 30% fewer children died.

Was this a protective effect of school closures? Were teenagers getting themselves into risky situations at a lower rate? No. There was very little effect among school age children or adolescents.³⁴

Incidentally, since the publication of Blaxill and Becker's article, the CDC has removed the page that memorialized the fact that almost all of the reduction in childhood deaths came from infants. Blaxill and Becker explain that the CDC statistics showed:

Virtually the entire change came from infants. Somehow, the changing pattern of American life during the lockdowns has been saving the lives of hundreds of infants, over 200 per week.

What has changed during this period that might have such an effect?

One very clear change that has received publicity is that public health officials are bemoaning the sharp decline in infant vaccinations as parents are not taking their infants into pediatric offices for their regular well-baby checks. In the May 15 [2020] issue of the CDC Morbidity and Mortality Weekly Report (MMWR), a group of authors from the CDC and Kaiser Permanente reported a sharp decline in provider orders for vaccines as well as a decline in pediatric vaccine doses administered. Santoli, Jeanne M et al. Effects of the COVID-19 Pandemic on Routine Pediatric Vaccine Ordering and Administration — United States, 2020. cdc.gov.³⁵ [Online] May 15, 2020. These declines began in early March, around the time infant deaths began declining.³⁶




Figure 2: Chart showing a precipitous drop in child deaths early in 2020 that correlated directly with the COVID-19 lookdowns. Virtually the entire drop in deaths among children under 18 years old came from infants. The COVID-19 lockdowns prevented parents from taking infants for well-baby checkups and getting vaccinated. The reduction in infant deaths also correlated directly with a sharp decline in provider orders for vaccines and a decline in pediatric vaccine doses administered.

A 2011 study compared the infant mortality rate (IMR) of 34 countries to the number of vaccines required by their 2009 national vaccine schedule within the first year of infancy.³⁷ If vaccines were safe and effective, as the pharmaceutical companies and the CDC claim, the greater the number of childhood vaccines would mean a lower infant mortality rate. But the opposite was found. The study revealed a direct correlation between the number of childhood vaccines and the mortality rate. The more vaccines administered to infants, the higher the infant death rate.

In 2009, the U.S. vaccine schedule called for 26 vaccine doses within the first year after birth, and the infant mortality rate in the U.S. was 6.22 per 1,000. The U.S. had the highest number of infant vaccines of all 34 countries in the study. The report also found that the U.S. had the highest infant mortality rate among all 34 countries. The researchers explained:

Despite the United States spending more per capita on health care than any other country, 33 nations have better IMRs. Some countries have IMRs that are less than half the US rate: Singapore, Sweden, and Japan are below 2.80. According to the Centers for Disease Control and Prevention (CDC), "The relative position of the United States in comparison to countries with the lowest infant mortality rates appears to be worsening."

The infant mortality rate is expressed as the number of infant deaths per 1000 live births. According to the US Central Intelligence Agency (CIA), which keeps accurate, up-to-date infant mortality statistics throughout the world, in 2009 there were 33 nations with better infant mortality rates than the United States. The US infant mortality rate of 6.22 infant deaths per 1000 live births ranked 34th.

Vaccination is not based on science; it is based on religion. The religion of Molech. Parents obediently march their children to the pediatrician, who, like a priest of Molech, administers deadly poison to the children. The religious mantra is that vaccines are safe and effective; only a few will die. The few must die for the benefit of the many. Among the many surviving children, there will be those who will suffer lifelong ailments. And like Molech, the protection is a myth.
